

# RED HOT FUN FOR KIDS

## RULES OF CASTLE AND RIDE HIRE

(hirer must print out and sign and date)

To be presented with payment upfront on day of hire.

1. Our Company is named 'A ABOUT CHILDRENS PARTY ENTERTAINMENT TAS RED HOT FUN FOR KIDS'. The contents of the entire disclaimer is in referral to the above named Company. Red Hot Fun For Kids provides the equipment hire of Castles, Slides and Rides.

2. Free Supervision is offered with any hire of equipment. Hirer acknowledges that the supervision is offered as a free service and that the supervision is not an actual childcare service. Hirer acknowledges that the free supervision is only to assist in the prevention of accidents and that the supervision does not guarantee that an accident will not occur and that the hirer is one hundred percent responsible for the safety of jumpers and riders. The hirer agrees that the complimentary service of free supervision will be of assistance and not hindrance in the prevention of accidents.

3. Free Supervision is is of activities involving the equipment while in use. Including supervision of the approximate age and numbers of children riding, jumping or sliding on supervised hire equipment at any given time. Hirer acknowledges that the hirer and/or individual children's parents are responsible for actual supervision and the childcare of their children's' activities.

4. Bad Weather including, Storms, Rain, High Winds and Overly wet/muddy/slippy ground area will cause the cancellation of equipment hire. Red Hot Fun For Kids reserves the right to cancel under these circumstances. We cannot be held responsible for acts of nature which cause an unsafe environment for children to be partaking in activities involving the equipment. If equipment is already in use at a hire when weather or conditions change and equipment becomes unsafe for continued use, the hire will be stopped. Equipment will be packed away and no refund will be given. In circumstances where the weather is ideal but a storm or bad weather warning has been issued, Red Hot Fun For Kids, will contact the hirer and ask if the client would like to take the risk of hiring the equipment anyway. Should the hirer agree to continue with the booking, once again the hirer accepts that if the weather conditions do change that the hirer will be responsible to pay the full hire fee. In such conditions our Supervisors reserve the right to make full judgement on continued or discontinued hire behalf of Red Hot Fun For Kids **without refund**.

5. Electricity must be made available and within 20 metres of set up of equipment. If hirer is not able to provide an uninterrupted supply of electricity, Hirer will be required to pay an additional \$80 for hire of a generator. Hirer must inform of electricity availability upon booking. We cannot supply a generator without notice given.

6. Upon booking, the hirer must inform us of any of the following ground conditions.

If equipment will be set up on sand, grass, concrete, bitumen.

If there is drive through access to the set up location.

Hirer accepts that Red Hot Fun For Kids is not liable for any accidents or injuries sustained whilst hirer and hirers guests are using the equipment.

Waterslide must never be deflated whilst water is still in the basin as the water will flood the chambers. (UNLESS BAD WEATHER EMERGENCY).

Hirer will pay for any damage to equipment that has been caused by the dishonouring of these rules.

Hirer acknowledges that hirer is hiring equipment only and accepts responsibility for all person engaging in use of equipment.

Hirer accepts the supervisors as complimentary assistance only and that although the supervisors are on location to keep equipment protected that the supervisors show care by offering assistance with supervision of persons on equipment.

Hirer will explain within reason to guests and parents of guests , the activities which will be involved with the hire and explain the rules and regulations of the hire.

9. Mum and dad can request time on the equipment in relation to bouncing with their toddler. All other children will be instructed to vacate equipment, so that mums' and dads' can spend special time with infants and toddlers in a safe environment. Please speak to the Supervisor on the day of hire to arrange this.

10. Although Contractors/ Staff/Supervisors expect the occasional misbehaviour from children, hirer must agree to take reasonable and responsible measures to prevent any violent verbal or physical behaviour from any person whether it be Adult or Child toward any of our Contactors/Staff/Supervisors. Hirer acknowledges and agrees that in circumstances where unacceptable behaviour occurs, that the services and/or hire will be cancelled **without refund**.

**11. Hirer agrees and acknowledges that injury is a risk factor when partaking in any sporting activity and hirer personally accepts this risk when hiring equipment and agrees not hold A ABOUT CHILDRENS PARTY ENTERTAINMENT TAS RED HOT FUN FOR KIDS responsible for any injury not caused by a pre existing fault of the hire equipment prior to use.**
